THIS IMPLEMENTATION AGREEMENT is made:

UNIVERSITAS AIRLANGGA represented Prof. Dr. Dian Agustia, SE.,M.Si.,Ak. as the Dean Faculty of Economics and Business, Universitas Airlangga, based on Rector's decree No. 831/UN3/2020 dated 30 September 2020, whose address is at Jl. Airlangga 4-6 Surabaya, Indonesia.

AND

UNIVERSITY of WESTERN AUSTRALIA, represented by Prof. Anu Rammohan as the Professor of Economics & Director of International Engagement, Business school, whose address is at 35 Stirling Highway, Perth WA 6009 Australia.

(Hereinafter referred to singularly as "Party" and collectively as "Parties").

Whereas:

- A. The parties are desirous of entering into this Implementation Agreement to declare their respective intentions and to establish a basis of cooperation and collaboration in academic interest, between the parties upon the terms as contained herein.
- B. Faculty of Economics and Business, Universitas Airlangga covers study programs as follows:
